Name of Facility

Eastminster Preschool, as a licensed child care facility, will provide the following provisions of the Michigan Administrative Code, as required by R400.5105b:

R 400.5102. Licensee.

- Rule 102. (2) A licensee shall have the following administrative responsibilities regarding staff.
- (b) Develop and implement a written screening policy for all staff and volunteers, including parents, who have contact with children.

R 400.5106. Program

- Rule 106. (1) A center shall provide a program of daily activities and relationships that offer opportunities for the developmental growth of each child in all of the following areas:
- (a) Physical development, including large and small muscle
 - (b) Social development, including communication skills.
 - (c) Emotional development, including positive self-concept
 - (d) Intellectual development.
- (2) A center shall permit parents to visit the program for the purpose of observing their children at all times.
- (5) A center shall provide children less than 3 years of age with an opportunity to rest.
